Sealed quotation received after this deadline will be rejected. Sealed quotation shall be opened in presence of Bidders' representatives who choose to attend at 13:00 hrs on 2077/12/03 (16th Mar 2021) at the office of Sarumarani Rural Municipality, Baddanda Pyuthan. Bids must be valid for a period of 45 days counting from the day of bid opening and must be accompanied by a bid security, amounting to a minimum of NRS 29,000.00 which shall be valid for minimum 30 days beyond the bid validity period (atleast 75 days from bid opening date, fill it yourself).
