- 7. Sealed bids must be submitted to the office of Sarumarani Rural Municipality, Pyuthan on or before 12:00 on Baishak-10, 2076for Contract 12/SRM/TECH/2075/076, Bids received after this deadline will be rejected.
 - The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00, on Baishak-10, 2076for Contract 12/SRM/TECH/2075/076at the office of Sarumarani Rural Municipality, Baddanda Pyuthan. Bids must be valid for a period of 90 days for Contract 12/SRM/TECH/2075/076 from the bid opening date and must be accompanied by a bid security amounting to a minimum of following amount, which shall be valid for 30 days beyond the validity period of Bids.
